- A17/13 Adoption of Terms of Reference for the DenMisch simulated ring: Alison Waterson introduced the previously circulated draft Terms of Reference document, advised that it had been reviewed by the officers, and invited any comments. An amendment to the responsibilities of the Management Committee (point 7) was tabled (p: Lester Yeo, s: James Kirkcaldy) and accepted unanimously.

- A17/14 Report from Central Council Meeting at Edinburgh: Fergus Stracey presented his report on the Central Council Meeting held in Edinburgh, which was attended by two out of the four Guild representatives.
 - The main points of note were that the representative fee was to increase by £10 and that the annual meeting would move to September.
- A17/15 Fundraising: Date of Quarter Peal Festival 20th October 5th November 2017: James Kirkcaldy (Quarter Peal Secretary) once again asked that members link their performances on Bellboard.
- A17/16 <u>Guild 6 and 8-Bell Striking Competitions:</u> Leslie Boyce confirmed that the Guild Striking competitions would be held on Saturday 21st October and hosted by the North East Branch. The 6-bell competition would be held at Stoodleigh, the Novice competition at Bampton, and the 8-bell competition at Silverton. Refreshments would be available at Silverton church hall.
- A17/17 Proposal to Introduce a Novice 8-Bell Striking Competition: Alison Waterson introduced the proposal to implement a novice 8-bell striking competition and asked Alena Wardle to speak to the proposal. Alena explained the intention is to create opportunities for the less experienced to take part in an 8-bell striking competition and that the proposal had already been considered and recommended by the Guild Committee. After some discussion Alena proposed a vote; this was seconded by Nigel Birt and passed unanimously. The Guild Committee would work towards introducing the new competition in 2018.
- A17/18 <u>Guild Festival and Annual General Meeting 2018:</u> Rodney Horder invited members to attend the meeting that the Mid-Devon Branch would be hosting on Saturday 16th June 2018 based at St Paul's church, Newton Abbot.
